The organization shall be known as, NACC-The Internal Province of Amadi. Herein, NACC is referred to as North America Centenary Committee. We, the North America Centenary Committee-The Internal Province of Amadi, are aware of our very existence and growing population as a community, and desire to organize ourselves into an organization to carry out beneficial activities for our Greater Mundri Community and contribute to the general well-being of South Sudan.

## The Objectives of NACC- The Internal Province of Amadi are to:

- ✓ To review and record the experiences and lessons learned during the 100 Years spanning the period 1920-2020 of the introduction of Christianity, Enlightenment, Health, and Education by Dr. Kenneth Fraser his wife Mrs. Eileen Fraser in Lui, in the Greater Mundri Region of The Internal Province of Amadi, in South Sudan.
- ✓ Build a Global Coalition for progress in Greater Mundri
- ✓ Promote sustainable peace, harmony, and unity throughout Greater Mundri.
- ✓ Provide opportunities for charting strategies for cooperation and coordination between the Church (The Internal Province) and the State in the delivery of services, economic development, and reconciliation.
- ✓ Apply and promote the experiences and lessons learned to support the Greater Mundri Community to adopt self-help in continuing to expand and improve their basic social services and development in the next 100 Years of Enlightenment.
- ✓ Identify challenges faced in Greater Mundri region and seek solutions to address them.
- ✓ Prepare to address emerging disasters through humanitarian programs.
- ✓ Promote harmony and cooperation with neighboring communities to Greater Mundri

### The functions of NACC- The Internal Province of Amadi are to:

- Ensure access to social services such as, education, social welfare, health, and economic development opportunities for all citizens of Greater Mundri through humanitarian actions.
- Advocate for good governance, and human rights advancement.
- Promote gender equality
- Educate all citizens of Greater Mundri about the rich cultures of the region
- Engage national institutions, churches, and the international community in advocating for lasting peace throughout South Sudan.
- Promote rehabilitation and development progress of Greater Mundri.
- Evaluate and assess the success and lapses of the programs initiated over the one hundred years
  in education, health, Christianity, especially their impacts on the people's livelihood, customs
  and traditions and identify the Lessons Learned for future applications to socio-economic
  development programs by recording accurately for posterity the events that took place over the
  one hundred years.

#### The Means

NACC- The Internal Province of Amadi will achieve the stated objectives by:

- ✓ Mobilizing the community at large to achieve the goals of the organization.
- ✓ Organizing fundraising events.
- ✓ Engaging the community nationally and internationally in innovative thinking through social media, local televisions, radio, newspapers, and other networking means.
- ✓ Organizing cross-cultural dialogues among the communities around Greater Mundri.
- ✓ Reaching out to members in the diaspora, as well as national and State government to share and discuss ideas.
- ✓ Collaborating with UN, INGOs/NGOs working on development.
- ✓ Identifying and convening leadership coalition meetings.
- ✓ Any Greater Mundri community member who is 18 years of age and above who believes in the vision and mission of the organization and adhere to this organization shall be a member.

The officers and agents of NACC- The Internal Province of Amadi can be any Greater Mundri community member or associate member (friends and supporters of the organization) who:

- ➤ Believe in the mission of the organization and possesses the qualifications needed for the directorates shall be selected through a procedure to carry the work of the organization.
- Are willing to volunteer and carry out the duties and commit to follow through with assignments given them.
- ➤ Have commitment and interest to work in resolving intercommunal issues in the Greater Mundri and the surrounding areas.
- > Have creative and ability to develop achievable program/s.
- Are willing to work as a team.

## The Chairperson

The Chairperson shall provide oversight on leadership and maintain the interest and focus of the organization. He/she shall facilitate good board governance and set the tone for the meeting while working in collaboration with the CEO. He/she also set goals and objectives for the board and ensures that they are met. The Chairperson shall act as an ambassador for the organization; develop and manage relationships and communicate with stakeholders, funders, and partners.

### **Executive Director**

The Executive Director shall be the Chief Executive Officer of the organization and subject to the directives of the board, shall oversee the supervision and of the affairs of the organization. If the chairperson of the Board of Directors is not elected, the executive director shall preside at all meetings of the board, except when the directors determine otherwise.

# Secretary General (SG)

The Secretary General shall record and maintain records of all proceedings of the Directors in a book or file. Such book or file shall also contain records of all meetings of the organization and the original, or attested copies, of the Articles of Incorporation, By-Laws, names of all Directors and their addresses. If the SG is absent from any meeting of directors, a member of the committee chosen at the meeting shall exercise the duties of the SG at the meeting.

### **Treasurer**

The Treasurer shall be the Chief Financial Officer and the Chief Accounting Officer of the organization. He/she shall oversee its financial affairs, funds, securities, and valuable papers and shall keep full and accurate records. He/she shall also oversee its books of account and accounting records, and of its accounting procedures. It shall be the duty of the treasurer to prepare or oversee all filings required by the state in which the organization is incorporated, the Internal Revenue Service, and other federal or state agencies. He/she shall have such other duties and powers as designated by the directors or executive director.

#### Coordinator

Establishes and maintains the organization networking channels including website, list servers, and other social networking tools. Maintains organizational schedules by maintaining calendars for arranging meetings, conferences, teleconferences, and other events. Circulates meeting reminders. Produces and disseminates information through newsletters and other distribution channels including but not limited to mass-emails, television, and radio. Reads and route correspondences, collecting information, and initiate telecommunications. Secures information by completing database backups. Establishes Outreach to the global Greater Mundri community to initiate and form constituents. Mobilizes and organizes the global network. Compiles a database of all members affiliated with the organization.

# **Chairperson NACC Development Committee**

The Chairperson shall provide overall leadership to the roll out of the NACC development program through the areas of education, health, and economic empowerment. She/he shall oversee and ensure the planning, implementation, monitoring, and evaluation of the programs.

### **Gender, Women and Youth Coordinator**

The Gender, Women, and Youth Officer shall lead and promote the role and participation of Greater Mundri women and youth in the Centenary Celebration. The Officer shall promote gender equality and ensure the empowerment of women and youth is central to the NACC development program. She/He shall design, manage, strengthen, and provide direction of a holistic and robust strategies to promote equality and inclusion of women, and youth into all activities and throughout the development program.

### **ADVISORY BOARD**

To be formed from reputable members or non-members who believe in the bylaws of NACC- The Internal Province of Amadi. Such advisors shall be people with proven skills and good track records. Promote learning - discussions, research, publications, and advocacy.
